





The "NT Barramundi Classic" is an event organised by the Darwin Game Fishing Club. All competitors must be financial members of the Darwin Game Fishing Club.

## Please note that these are provisional rules as at 28 December 2020 and there may be some minor changes prior to the 2021 NT Barramundi Classic

Introduction

The following rules will apply to the 2021 NT Barramundi Classic. All skippers must sign the Rules Acknowledgement Form agreeing to comply with these rules, prior to the first day of the competition.

### **Tournament Coordinators**

Tournament Coordinator/s: Debbie and Leigh Halprin

The Tournament Coordinator/s will be responsible for the following:

- Control and enforcement of the rules and conditions of entry. Any disputes or rule enquiries will be referred to the Tournament Coordinator/s for determination during the running of the event.
- Chair the Dispute Committee
- Supervise all areas of the venue
- If required, refuse access, move people on, and direct that persons leave the venue.
- Hold the liquor licence and relevant control relating to the supply and service of alcohol.

### **General Conditions**

All competitors must be members of the Darwin Game Fishing Club.

Competitors participate in the 2021 NT Barramundi Classic entirely at their own risk and acknowledge and agree that neither Darwin Game Fishing Club or its servants, agents or contractors will under any circumstances be legally liable for any loss or damage suffered by competitors of whatsoever nature (including death, injury or loss or damage to personal property) irrespective of how such loss may be caused, including loss or damage caused by a negligent or deliberate act or omission of the Club or its servants, agents or contractors.

Competitors acknowledge that the insurance policy of the Darwin Game Fishing Club includes the tournament venue, but does not extend to the river, and evidence of individual boat insurance must be provided prior to the tournament commencing.

Competitors will not do anything to bring the Darwin Game Fishing Club, the NT Barra Classic or the NT Barra Classic venue into disrepute.

The NT Barra Classic has not been sanctioned by NTGFA and therefore any fish record claim lodged will almost certainly be rejected. As this is strictly a tag and release tournament, no fish are to be taken and all fish are to be released.

Skippers acknowledge that they are responsible for their crew's safety. They will not behave irresponsibly or place anyone in a dangerous situation. They must ensure that their boat is in good condition and carries all safety equipment stipulated by the NT Marine Act.

Competitors must abide by the rules of the Darwin Game Fishing Club and participate in the good spirit, sportsmanship and the tradition of the NT Barra Classic.

Competitors acknowledge that they have read the rules carefully and have signed the Acceptance of Rules form prior to the commencement of the 2021 NT Barra Classic.





The tournament venue is a licensed premises and alcoholic beverages cannot be brought into the NT Barra Classic area.

### **Team Sheets and Payment of Entry Fees**

The club must receive completed entry forms for each team members (or at least the skipper if your team is not yet complete) along with the team deposit of \$2660 by no later than Friday 29 January 2021. The balance of the entry fee must be received by Friday 12 March 2021.

#### Cancellation

Competitors acknowledge and agree that if the Darwin Game Fishing Club decides to postpone and/or cancel the 2021 Barra Classic for reasons outside of the control of the Club, or not reasonably foreseeable by the Club (such as an outbreak of a pandemic, a flood, the imposition of biosecurity restrictions, a natural disaster, an outbreak of war, or civil unrest), then the Club will endeavour to offer teams the option of carrying forward their entry to a future Barra Classic, or providing a refund of entry fees. Any refund of fees will not include airfares or travel costs associated with interstate competitors, nor the cost of Quarantine, if imposed by the NT Government or Commonwealth Chief Health Officer.

Any refund of entry fees, or carrying forward of entry fees to a future competition, will be subject to such deductions as the Club, acting reasonably, determines as representing the expenses incurred by the Club in preparation for the cancelled or postponed event. We acknowledge and agree that we will have no claim against the Club for any failure by the Club to offer a refund or for any deductions made by the Club in accordance with this clause.

### **Breaches of Rules and Clarifications**

At the completion of each competition fishing day, the Marshals will report to the Dispute committee and inform the Dispute committee of each day's Marshalling report and issue the Dispute committee their check list for alleged breaches of the tournament rules.

If any breaches are issued for investigation by the Marshals, the Dispute committee will then investigate the alleged breach, if the Dispute committee confirms a breach has occurred the Skipper of that team will be requested to attend a private area. One of the Dispute committee members will then explain the breach to the team Skipper and advise the Skipper of the penalty the breach incurs.

The Dispute Committee will comprise a minimum of three non-competing NT Barra Classic officials. Once the Dispute Committee has made a decision, one of the Dispute Committee members will discuss the outcome with the skipper of the team in a private area. If the team Skipper is not available, the Dispute Committee member will discuss the outcome with another member of the team in a private area.

The Dispute Committee officials may consult a pre-nominated member of the Darwin Game Fishing Club Committee to verify the NT Barra Classics rules for clarification of the rules if necessary.

The Dispute Committee member will also inform the Skipper at that time, that if a subsequent breach of the rules is verified by any of their team, the entire team will be disqualified from the competitive section of the Tournament. It is the responsibility of the Skipper to inform their team of what will occur if the team incurs a subsequent breach of the Tournament rules.

The Dispute Committee's decision will be final and no further discussion will be entered into.

At the completion of the investigation, the Tournament scorers will be advised of the details by a member of the Dispute Committee to ensure the competitors and team scores are recorded accurately.
